IN-PERSON CONFERENCE REFUND / CREDIT POLICY

If purchased to attend the in-person conference as a separate item (not included in membership fees) and full price is paid for the conference:

- If less than 30 days' notice, no refund. Opportunity to shift your registration from in-person to virtual attendance.
- If less than 30 days' notice and the conference is missed due to a family or emergency issue, submit a request in writing to the board as to the reasons for not attending the conference. The board can allow a credit to transfer as payment for the following conference. Rollovers are only permissible if due to extenuating circumstances and must be approved by the board on a case-by-case basis.
